The regular working hours for this position is weekday evenings with daytime shift options and may change seasonally.

- Responsible for oversight and staff leadership for Aquatics staff on duty during your shifts.
   Programming safety and quality with aim of ensuring inclusive, meaningful, and positive environment that enhances the achievement of participant whole-life health and wellness goals. Develop, monitor, improve and evaluate aquatics programs ensuring high level member satisfaction, engagement, and retention. Ensure program delivery is in keeping with the Y Way, safety, and child protection standards.
- Build, foster, and maintain positive working relationships with participants, community
  members, staff and volunteer in efforts to enhance and promote our Y profile in the
  community. Implement recommendations to enhance participant satisfaction, engagement,
  and retention to ensure the delivery of quality aquatics programming.
